

# WELCOME



Since Redwood Coast Land Conservancy's last community report in 2021, I can attest, as a volunteer back then now serving as RCLC president, that much has changed.

In 2021, the newly acquired Mill Bend Preserve seemed more an idea than a place for an afternoon's walk. Today the Preserve now offers the River Rail and Toyon Trails, with plans continuing for an extension of the California Coastal Trail from the Gualala Bluff Trail to the Highway 1 bridge.

Invasive plants, once dominant in areas scarred by lumber mill operations, are yielding to volunteers with weed wrenches, shovels, strong arms and backs. Cleared areas are infilling with native plants.

No single effort, however, outshines the ongoing restoration of the Gualala Cemetery. An overgrown and nearly forgotten sacred space has again become a beautiful place of contemplation and remembrance. No other accomplishment better exemplifies whats possible when our RCLC community unites.

RCLC is experiencing a growth spurt, despite its 30-year-old age. With Mill Bend Preserve secured in 2021, and the State Coastal Conservancy-funded Conservation Plan delivered in the fall of 2022, RCLC is now actively restoring native habitats and designing an expanded trails network, including natural and cultural history interpretation. The cemetery revitalization team is putting finishing touches on its makeover efforts.

Recognizing the workload and opportunities ahead, RCLC hired me as its first full-time executive director last year. Having devoted my professional life to land conservation, I was able to jump right in and get to work.

RCLC is building its future on a foundation of already-beloved projects. Cooks Beach and Hearn Gulch continue to provide access to rugged Mendonoma coastlands. The Gualala Bluff Trail still invites residents and visitors alike to pause and absorb nature's grandeur.

# CONNECTING COMMUNITY



### MILL BEND PRESERVE

MILL BEND PRESERVE WILL HEADLINE RCLC'S RESTORATION EFFORTS FOR QUITE SOME TIME. NATURE HAS BEGUN TO HEAL ITSELF, THOUGH IT COULD USE SOME HELP. MILL DEBRIS AND RUSTING VEHICLES REMIND US OF MILL BEND'S BRIEF BUT IMPACTFUL INDUSTRIAL PAST.

INVASIVE PLANTS FOUND A FOOTHOLD, UNDERMINING NATIVE SPECIES AND RAISING WILDFIRE CONCERNS FOR THE NEIGHBORING COMMUNITY. AND GUALALA'S HISTORIC CEMETERY FELL VICTIM TO NEGLECT AND OCCASIONAL VANDALISM.

On-the-ground restoration efforts are well under way. Together with energetic volunteers, we have removed more than 50 tons of downed debris and invasive jubata and broom plants. Sea Ranch "Hot Shots" rebuilt the River Rail Trail, following the original Highway 1 alignment to the corridor where trains once carried logs to downstream mills. And skilled craftspeople have fully renovated the Gualala Cemetery, honoring and providing a glimpse into the lives of those at final rest there.

#### **COMING SOON**



Expanded native habitat restoration, thanks to a \$268,000 State Coastal Conservancy Wildfire Resilience Program grant, accelerating the removal of invasive plants and downed debris, benefiting wildlife and the community alike.



Salmonid habitat restoration, funded by a \$404,000 California Department of Fish and Wildlife grant. Our partners at Prunuske Chatham, Inc. will design a road map for using woody debris, deepened pools, and braided river channels to improve coho salmon and steelhead trout habitats.



Public access and trails master plan. RCLC is applying for a \$1.3 million State Coastal Conservancy grant to guide future trails, scenic sitting areas, and interactive natural history education. With Prunuske Chatham, Inc. as technical partners, we will extend the California Coastal Trail beyond the Gualala Bluff Trail and through Mill Bend, plus add interior trails. Lower Preserve designs will include an elevated walkway and a river viewing platform.

### **2022 FINANCIALS**

RCLC is on strong financial footing. Individual donors and businesses support more than half our work. Public agency grants fund Mill Bend Preserve habitat restoration and trails development. Looking forward, RCLC plans to grow staff and outreach capacity to advance conservation goals, while applying the same prudent fiscal management principles that have guided RCLC for more than 30 years.
